MEMORANDUM OF ASSOCIATION.

- (1) Name of the Association. : The name of the Association is "Vokkaligara Sangha, Narasimharajapura Taluk, Narasimharajapura Chikmagalur Dist. PIN - 577 134. hereafter called the "Sangha".
- (2) Address : The Head Quarters of the Sangha shall be at Vokkaligara Sangha Building, Thyagaraja Road, (Old Mandagadde Road), Narasimharajapura - 577 134. Chikmagalur Dist.
- (3) The Object of the Sangha : The Aims and Objects of the Sangha shall be:-
- (a) To uplift the living conditions of the Vokkaliga community, of Narasimharajapura Taluk, in Chikmagalur Dist, who are basically depending on Agriculture and Animal Husbandry, and who are backward in education and also in other aspects like social, economical and political,
- (b) To establish and maintain educational institutions like pre-primary schools, Primary and High Schools, Pre-University Colleges, Vocational Schools, Industrial Training Institutions and Colleges for providing education facilities to the Publics in general and to the Vokkaliga Community in particular of N.R.Pura and other Taluks in Chikmagalur and Shimoga Districts, who are backward not only in education, but also in social, political and economic aspects.
- (c) To take over the control and managements of the Private or government education or Technical institutions,
- (d) To develop discipline, good conduct and a healthy as well as creative attitudes and thereby enable the students and all those connected with the institution to become good citizens, by developing them-Physically, Mentally & Morally or spiritually,
- (e) To establish and maintain Residential Institutions for the benefits of the students of rural areas.
- (f) To establish and maintain Libraries and Reading Rooms and also Audio-visual equipments for the diffusion of knowledge and education for the benefit of the students and General publics.
- (g) To encourage and to give training in sports, physical education, wrestling, yoga, karate, etc. and to develop adventurous spirit in the students and to develop patriotism among the younger generation.



- (h) To enter into any agreement or arrangements with the Government or other authorities- Municipal or Local Authorities. Which are conducive to the furtherance of all or any objects of the Society and to obtain from such sources any rights and privileges, assistance and concessions which the Sangha feels suitable and desirable,
- x (i) To acquire by grants from the Govt. or by purchase lease gift, mortgage, licence or as a beneficiary under any other Trust, or by any institutions or individuals movable or immovable properties and to sell, gift, lease, mortgage or in any other way alienate such properties for the furtherance of the furtherance of the objects of the 'Sangha'.
- x (j) To collect funds by way of subscriptions and by organising cultural shows, accept donations, grants presents and other offerings in cash and/or kind, subsidies, loans, etc. from individuals, institutions, Government etc. and to utilise the same for the objects of the 'Sangha'.
- (k) To award scholarships, fellowships, stipends, or any other form of assistance - financial or otherwise - to the needy and deserving students for prosecuting their studies.
- x (l) To borrow or otherwise raise money from Banks or Financial Institutions on such terms and conditions as the committee members may deem fit.
- (m) To do such things and acts that are incidental or conducive to the attainment of the objects of the 'Sangha'.
- (n) To open branches and - or educational institutions, Hostels, Residential Institutions, etc in attaining the above objects anywhere in Chikmagalur and Shimoga Districts,
- (o) To organize social service-camps like free Medical camps, Free eye camps etc. for the benefit of the poor and deserving people belonging to Chikmagalur and Shimoga Districts.
- (4) The income of the Sangha by whatever means it is realised shall not be distributed among, its members or anybody, but shall be utilised for the fulfilment of the objects of the 'Sangha'.
- (5) Sri. H.T. Rajendra, B.Sc., the Secretary of the 'Sangha' is authorised to correspond in all the matters pertaining to the "Sangha".

 - (a) THE SANGHA, shall mean Vokkaligara Sangha.
 - (b) RULES means, the Rules and Regulations of the Vokkaligara Sangha.
 - (c) COMMITTEE shall mean and include the executive committee to which the management affairs of the Sangha are entrusted.
 - (d) MEMBER OF THE COMMITTEE shall mean the member of the Executive committee which includes office bearers as well.
 - (e) MEMBER shall mean and include the life and patron member of the Sangha.
 - (f) PRESIDENT, VICE-PRESIDENT, SECRETARY, JOINT SECRETARY and TREASURER mean the president, Vice-President, Secretary, Joint Secretary and the Treasurer of the Sangha for the time-being in office.
 - (g) FINANCIAL YEAR shall mean the period from 1st ~~January~~ ^{April} to 31st ~~January~~ ^{March} ~~December~~ of every year.
4. AREA OF OPERATION: The area of operation of this Sangha shall comprises of Chikmagalur ~~and Shivamogga Districts.~~ *District only.*
5. MEMBERSHIP :-
 - (a) There shall be two classes of members i.e., patron Member and Life-Member. (i) Patron Member - Those who contribute Rupees One Thousand or more to the Sangha in addition to the prescribed subscription of Rs. 25 i.e., Life Members fees, (ii) Life-Member: Those who subscribe Rs. 25/- to the Sangha. The Membership fees once paid can not be refundable.
 - (b) The membership is open to those persons who belongs to Vokkaligara Community and who have completed eighteen years of age, at the time of registration. The person who desires to become a Life-Member and patron Member shall apply for membership in the prescribed form. Admission of the member shall be made with the approval of the Executive committee. The members so admitted shall pay the enrolment fee subscriptions and other charges as may be prescribed from time to time. - All the applications

should be disposed off before 45 days of the annual General Body of every year and no fresh enrolment should be made before the Annual General Body.

(c) The persons of eminence, Government officials, Bank officials, Doctors, Lawyers, Engineers, Architects, Professors and Social workers Members of the Legislative Assemblies, Members of the Legislative Councils, Members of the Parliament, Scientists etc., who belong to the Vokkaliga Community may be admitted as honorary Members. Such members may be admitted at the sole discretion of the Executive Committee. However, such members shall work for the promotion of the objects of the Sangha and shall abide by and be subject to the Rules & Regulations and Bye-laws of the Sangha. ~~The Honorary Members are not entitled to pay the enrolment fee, subscription and other charges and no voting rights in the General Body Meetings and in the Extra-ordinary General Body Meetings.~~ However such ~~members~~ members are entitled to give their valuable suggestions and advices to the Sangha, *by attending the General Body Meetings & the Extra-ordinary General Body Meetings.*

(d) There shall be a Register the enrolled Members in which the names of all members of the Sangha shall be entered with their name and addresses, age, occupation with their signatures.

6) SUBSCRIPTIONS :

- (a) The enrolment fees for the Life-Membership shall be Rs. 25/= (Rupees Twenty five only.)
- (b) All the applications for the membership shall be disposed off before 45 days of the Annual General Body and no fresh admission done till the time of Annual General Body Meeting.

 - (c) Upon the death of the member,
 - (d) On his becoming insolvent,
 - (e) On his becoming in same or incapacitated,
 - (f) On conviction by a court for moral turpitude.

8) MEETINGS:
